

The BROADVIEW TEN GRAND Sweepstakes
OFFICIAL RULES

NO PURCHASE, PAYMENT, TRANSACTION OR LOAN NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT, TRANSACTION (OPENING A NEW CHECKING ACCOUNT, CERTIFICATE, OR RECEIVING FUNDING FOR A PERSONAL OR VEHICLE LOAN TO OPEN A NEW BROADVIEW FCU ACCOUNT) WILL NOT IMPROVE YOUR CHANCES OF WINNING. SWEEPSTAKES OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE STATE OF NEW YORK WHO ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. ELIGIBILITY: The “Broadview Ten Grand” Sweepstakes (“Sweepstakes”) is open only to permanent legal residents (having either a social security number [SSN] or tax identification number [TIN]) of the state of New York, who are eighteen (18) years of age or older at the time of entry. Employees and volunteers of Broadview Federal Credit Union (“Sponsor” or “Broadview FCU”), Mintz + Hoke, Working Pictures Inc., their respective subsidiaries, advertising/promotion agencies, and their immediate families (spouse, parents, IRS dependents, children and siblings and their respective spouses) and/or those living in the same household of such employees, whether related or not, are not eligible to participate. Sponsor reserves the right to verify eligibility qualifications of prize winner. Sweepstakes is subject to all applicable, federal, state, local laws, and regulations. Sweepstakes is void in all other United States and U.S. territories and possessions, overseas military installations and wherever else prohibited or restricted by law. By participating in the Sweepstakes, entrants agree to be bound by these Official Rules which are final and binding on all matters pertaining to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements described in these Official Rules.

DESCRIPTION & SWEEPSTAKES TIMING: The Sweepstakes starts at 12:00 a.m. Eastern Time (ET) on May 1, 2025 and ends at 11:59:59 p.m. ET on June 30, 2025 (“Sweepstakes Entry Period”). Opening a Checking Account with Direct Deposit, Certificate, or receiving funding for a Personal or Vehicle Loan are not required for entry nor will doing so improve the chances of winning the prize. Limit three (3) Sweepstakes entries per account regardless of entry method. Sponsor’s computer will be the official timekeeping device for this Sweepstakes.

HOW TO ENTER: There will be two (2) methods of entry into the Sweepstakes, as further detailed below:

1. **Automatic Entry Method (with opening a new Checking Account with Direct Deposit, Certificate; or Receiving Funding for a Personal or Vehicle loan)**: Consumers (current or new members) are eligible to receive one automatic entry **for each** of the following actions completed in person at a Broadview FCU branch location or online via electronic banking at: <https://www.broadviewfcu.com/10grand> during the Sweepstakes Entry Period.
 - a. Open, fund, and maintain a new **Checking Account** (includes “Free Checking,” “Rewards Checking,” “Business Checking” and “Young Adult Checking”) with a new Direct Deposit.
 - b. Open, fund and maintain any new **Certificate** (all types, including a Certificate roll-over)
 - c. Receive funding for any new **Personal Loan** or **Vehicle Loan** during the Sweepstakes Entry Period to receive an automatic entry. A Vehicle Loan could include the following types of vehicles: automobile, Recreational Vehicle, boat or other type of sport craft. Approval of the type of vehicle for the loan will be at Sponsor’s discretion.

Limit of up to three (3) entries per person during the Sweepstakes Entry Period. The Checking Account with Direct Deposit or Certificate, or Personal or Vehicle Loan must be open and in use by the end of the Sweepstakes Entry Period to be eligible for the random drawing.

2. **Alternate Free Online Method of Entry (No Checking Account with Direct Deposit, Certificate, or Personal or Vehicle Loan Required)**: For eligible entrants to enter the Sweepstakes without opening either a **new** Checking Account with Direct Deposit, Certificate, or Personal or Vehicle Loan, please access the following website: <https://www.broadviewfcu.com/10grand>. To submit an alternate entry, entrants will be asked to provide their complete name, city, state, and email address. Limit of three (3) entries via the free online method of entry.

No type of Checking Account with Direct Deposit, Certificate, or Personal or Vehicle Loan is necessary to enter or win nor will they improve the chances of winning a prize. Proof of transmission (such as a “confirming” message received after an entrant submits contact information to open one of these Accounts, or receive funding for a Personal or Vehicle Loan, as mentioned above) does not constitute proof of receipt/delivery to serve as a Sweepstakes entry. Please be advised that you are only entering **The Broadview Ten Grand Sweepstakes** and will NOT receive an entry into any other sweepstakes at this time.

Any individual who attempts to/or is suspected of submitting more than three (3) entries with the same email address for the Sweepstakes Entry Period will be disqualified from participation in the Sweepstakes.

RANDOM DRAWING DETAILS: Random drawing will be conducted on/about July 15, 2025, by Marden-Kane, Inc., an independent judging organization, from among all eligible automatic and alternate entries received during the Sweepstakes Entry Period to award the prize. Odds of winning the prize will depend on the total number of eligible entries received for the random drawing. Decisions of the judges/Sponsor will be final and binding on all matters relating to this Sweepstakes. Potential winner is subject to verification of eligibility and compliance with these Official Rules. This is a randomized drawing that is not intended to and should not influence any decisions or actions for the benefit of the Sponsor. The Sweepstakes is in compliance with all applicable anti-corruption laws and regulations.

PRIZES: One (1) Grand Prize of a \$10,000 Account Deposit, if winner is a Broadview FCU member. If winner is not a Broadview FCU member, winner will receive a check for \$10,000. Prize is not transferable. No substitution allowed except, at Sponsor’s sole discretion, where a prize of equal or comparable value may be substituted. The winner shall bear all risk of loss to their prize after being delivered/deposited. Sponsor is not responsible for any unclaimed, lost, stolen or funds withdrawn without permission after being deposited; nor will said prizes be replaced. If due to a printing, production, technical, human or other type of error, more than one (1) prize is claimed than is to be awarded for the random drawing, as noted above, the intended prize in question will be awarded in a random drawing from among all verified and validated prize claims received for the prize. In no event will more than the stated number of prizes for the random drawing will be awarded. All details of prizes not specified herein shall be determined solely by Sponsor. Prize winnings must be reported to the IRS when filing your tax returns, and winners are solely responsible for paying any federal or state income taxes associated with their prize.

WINNER NOTIFICATION AND VERIFICATION: Potential winner will be required to complete and return an Affidavit of Eligibility and Publicity/Liability Release (“**Affidavit**”) and a W-9 Tax form before being awarded a prize (collectively the “**Prize Forms**”). These Prize Forms must be returned within five (5) business days of prize notification date. Prize award is subject to verification of potential prize winner’s identity and eligibility to Sponsor’s satisfaction. In the event that the potential winner cannot be contacted, and prize notification is undeliverable or if he/she fails to return the Prize Forms within the required timeframe, refuses the prize, or is disqualified for any reason, Sponsor will select an alternate potential winner in a random drawing from among all remaining eligible entries, if time permits, up to ten (10) alternates. If each of the alternate potential winners are disqualified, the applicable prize will not be awarded. No compensation will be given upon prize forfeiture.

BACKGROUND CHECK ON WINNER: Sponsor reserves the right to conduct a background check on the Grand Prize winner to verify their information, potentially including their criminal history or other relevant information, before awarding the prize. Any automated and/or electronic submission of entry (including but not limited to entries made using any script, macro, bot, or sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. If, in Broadview FCU's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if computer virus, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Sweepstakes, Broadview FCU reserves the right at their sole discretion, to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify or suspend the Sweepstakes, or to terminate the Sweepstakes and conduct a random drawing to award the prizes among all valid entries received as of the termination date. PRIVACY & PERSONAL INFORMATION: Personal information collected from entrants will be used by Broadview FCU only in a manner consistent with the consent given for the purpose of administering the Sweepstakes only. Broadview FCU shall not sell, share, or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Broadview FCU to fulfill the above purposes. Entrants are not required to opt-in to receive further communications from the Sponsor in order to participate in this Sweepstakes and opting in will not increase your chances of winning. DISPUTES: Except where prohibited, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice of law or conflict of law rules (whether of the State of New York, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of New York.

Except where prohibited, as a condition of participating in this Sweepstakes, each participant agrees that any and all disputes that cannot be resolved between the participant and any Released Party, claims and causes of action arising out of or connected with this Sweepstakes, or the prize awarded, or the determination of the winner must be resolved individually, without resort to any form of class action.
