

The BROADVIEW BUFFALO BLITZ Sweepstakes

OFFICIAL RULES

NO PURCHASE, PAYMENT, TRANSACTION OR LOAN APPLICATION NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT, TRANSACTION OR APPLYING FOR AN AUTO LOAN WILL NOT IMPROVE YOUR CHANCES OF WINNING. ELIGIBILITY: The “Broadview Buffalo Blitz” Sweepstakes (“Sweepstakes”) is open only to current permanent legal residents (having either a social security number [SSN] or tax identification number [TIN]) of the state of New York, who are eighteen (18) years of age or older at the time of entry. Employees and volunteers of Broadview Federal Credit Union (“Sponsor” or “Broadview FCU”), Mintz+Hoke, Working Pictures Inc., their respective subsidiaries, advertising/promotion agencies (“Sweepstakes Entities”), and their immediate families (spouse, parents, IRS dependents, children and siblings and their respective spouses) and/or those living in the same household of such employees, whether related or not, are not eligible to participate.

DESCRIPTION & SWEEPSTAKES TIMING: The Sweepstakes starts at 12:00 a.m. Eastern Time (ET) on November 1, 2025 and ends at 11:59:59 p.m. ET on November 30, 2025 (“Sweepstakes Entry Period”). A purchase, payment, transaction, or applying for an auto loan are not required for entry nor will doing so improve the chances of winning the prize. Limit one (1) Sweepstakes entry per account regardless of entry method. Sponsor’s computer will be the official timekeeping device for this Sweepstakes.

HOW TO ENTER: There will be two (2) methods of entry into the Sweepstakes, as further detailed below:

1. **Automatic Entry Method: Applying for an automobile loan:** Consumers (current or new members of Sponsor who reside in the state of New York) will receive one (1) automatic entry when purchasing an auto from one of Broadview’s participating automotive dealers in the Western part of New York state and financed through Broadview by the conclusion of the Sweepstakes at 11:59:59 p.m. ET on November 30, 2025. If the loan has two borrowers listed then the name of the primary borrower will be automatically entered.

Limit of one (1) entry per person during the Sweepstakes Entry Period.

2. Alternate Free Online Method of Entry (No Purchase, Payment, Transaction or Auto Loan Required): To enter Sweepstakes without a purchase, payment, transaction, or applying for or obtaining an auto loan, consumers will visit: www.broadviewfcu.com/blitz and follow the instructions to provide their full name, complete physical mailing address and e-mail address (to ensure residency in the state of NY) to receive one (1) Sweepstakes entry per email address. Limit of one (1) entry per person during the Sweepstakes Entry Period.

No type of purchase, payment, transaction or auto loan is necessary to enter or win nor will they improve the chances of winning a prize. Proof of transmission (such as a “confirming” message received after an entrant submits contact information to apply for the auto loan) does not constitute proof of receipt/delivery to serve as a Sweepstakes entry.
