## The Broadview Federal Credit Union Youth Savings Challenge Sweepstakes OFFICIAL RULES

NO PURCHASE, PAYMENT, ACCOUNT
DEPOSIT OR OPENING A NEW BROADVIEW SMART SENSE SAVINGS ACCOUNT
NECESSARY TO ENTER OR WIN.

SWEEPSTAKES OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND D.C. WHO ARE PRIMARY ACCOUNT HOLDER'S AND/OR ADULT JOINT OWNERS OF CHILDREN YOUNGER THAN EIGHTEEN (18) YEARS OF AGE AT THE TIME PRIZE IS AWARDED.

**ELIGIBILITY:** The Broadview Federal Credit Union "Youth Savings Challenge" Sweepstakes ("Broadview FCU Youth Savings Challenge Sweepstakes") is open only to legal residents of the 50 United States and District of Columbia, who are parent/legal guardians of children younger than eighteen (18) years of age who have an existing Broadview FCU membership with any of the following open type of accounts: 1) Broadview Smart Sense Savings Account, 2) any primary share, 3) smart sense share certificate, 4) preferred share, or 5) owners' choice as of May 27, 2023 for the first entry period at the time a prize is awarded. If a youth account has multiple joint owners, then the prize is awarded to the first joint owner listed on the account. Employees and volunteers of Broadview FCU ("Sponsor" or "Broadview FCU"), its subsidiaries, advertising/promotion agencies, and their immediate families (spouse, parents, IRS dependents, children and siblings and their respective spouses) and/or those living in the same household of such employees, whether related or not, are not eligible to participate. Sponsor reserves the right to verify eligibility qualifications of each prize winner. Sweepstakes is subject to all applicable, federal, state, local laws, and regulations. Void where prohibited by law.

**DESCRIPTION & SWEEPSTAKES TIMING:** The Broadview FCU Youth Savings Challenge Sweepstakes starts at 12:00 a.m. Eastern Time (ET) on May 28, 2023 and ends at 11:59:59 p.m. ET on October 28, 2023 ("Promotion Period") with five (5) monthly Entry Periods being (a "Sweepstakes Entry Period"), each a separate Sweepstakes. For each of the five Sweepstakes Entry Periods, entrant must be eligible by the day before the start of the particular entry period which correspond to: 5/27/23, 6/24/23, 7/29/23, 8/26/23 and 9/30/23, as noted below in the Random Drawing Schedule. There will also be a Grand Prize Drawing conducted on/about November 17, 2023 to award one (1) Grand Prize from all eligible entries received from April 30, 2023 to October 28, 2023. Eligible entries will include entries from both the Broadview FCU "Youth Savings Challenge" to be held from May 28, 2023 – October 28, 2023, as well as the SEFCU, Division of Broadview "Youth Savings Challenge" which was held from April 30, 2023 – May 27, 2023. A deposit of \$10 or more into a Broadview Smart Sense Savings Account will not be required for entry nor will the deposit improve the chances of winning the prize. Sweepstakes will be void where prohibited. Limit one (1) Sweepstakes entry per week per account with a maximum of one (1) Sweepstakes entry allowed per week, regardless of entry method.

**HOW TO ENTER**: There will be two (2) methods of entry in the Sweepstakes:

1. Automatic Entry Method: Each time a single deposit of \$10 or more is made into a Broadview Federal Credit Union Smart Sense Savings Account or any other type of existing Broadview Savings Account during the Sweepstakes Entry Period, either in person at a Broadview FCU branch location or online via electronic banking or by visiting: https://www.broadviewfcu.com/personal/youth-services/ permitted to one per week, one qualified entry is made into the drawing and will also be eligible for the Grand Prize drawing with the exception of dividends and youth banking incentives. One qualified entry can also be received for a new member by opening a new Broadview FCU Membership. Sweepstakes entries received for the random drawing will roll-over to be eligible for the Grand Prize random drawing to be conducted on/about November 17. 2023. Eligible entries will include entries from both the Broadview FCU "Youth Savings Challenge" held from May 28, 2023 – October 28, 2023, as well as the prior SEFCU, Division of Broadview "Youth Savings Challenge" held from April 30, 2023 - May 27, 2023. Sweepstakes entries will only be in the name of the adult primary account holder's adult joint owners on behalf of the minor aged child. The Broadview Savings Account must be open at the end of the Grand Prize and Sweepstakes Entry Period to be eligible for both drawings.

Sweepstakes entries received for a specific monthly Drawing will not roll-over to be eligible for any subsequent monthly Drawings, but entries received from each monthly drawing will roll-over to be included in the Grand Prize drawing. Sweepstakes entries will only be in the name of the adult primary account holder's adult joint owners on behalf of the minor aged child. The Broadview Smart Sense Savings Account must be open at the end of the Grand Prize and monthly Sweepstakes Entry Periods to be eligible for that specific drawing.

2. Alternate Mail-In Method: For existing Broadview members to enter the Sweepstakes without opening either a new Smart Sense Savings Account or without making a deposit of \$10 or more into a Broadview Smart Sense Savings Account, please print complete name, street address (no P.O. Boxes), city, state, ZIP code, daytime telephone number, and email address (optional) on a 3"x5" paper and place in a #10 size envelope that must have your full name and mailing address that is legibly hand written in upper left hand

corner on the outside of the envelope with only an affixed postage stamp that can be used to pay for postage fee (using a metered postage machine will not be accepted as a form of payment for postage and entry would be disqualified) and mail to: Broadview "Youth Savings Challenge Sweepstakes," 4 Winners Circle, Albany, NY 12205, Attn: Youth Banking. All mail-in entries must be postmarked by the last day of the monthly Sweepstakes Entry Period and received no later than seven (7) days later to be eligible for that specific Prize Drawing, as listed in the Random Drawing Schedule. Limit one (1) Mail-in entry per week per person. Sponsor is not responsible for entries received that are incoherent, incomplete, incorrect, misdirected, damaged, lost, late or postage due, all of which will be disqualified. Proof of mailing is not considered as an eligible entry in this Sweepstakes.

No type of payment, purchase, account deposit or new Smart Sense Savings Account necessary to enter or win nor will they improve the chances of winning the prize. Proof of transmission (such as a "confirming" message received after Entrant submits contact information to open a Smart Sense Savings Account) does not constitute proof of receipt/delivery to serve as a Sweepstakes entry. Please be advised that you are only entering **The Broadview FCU "Youth Savings Challenge" Sweepstakes** and will NOT receive an entry into any other Sweepstakes at this time. By participating in the Sweepstakes, all entrants agree to be bound by these Official Rules, which are final and binding on all matters pertaining to this Sweepstakes.

Any individual who attempts to/or is suspected of submitting more than one (1) entry per week for any Sweepstakes Entry Period will be disqualified from participation in that particular random drawing.

RANDOM DRAWINGS DETAILS: Random drawings will be conducted by an independent judging organization from among all eligible entries received for each Sweepstakes Entry Period and the Grand Prize Entry Period to award prizes, as indicated in the Random Drawing Schedule noted above. Odds of winning a prize for a specific Sweepstakes Entry Period will depend on the total number of eligible entries received for that particular random drawing. Decisions of the judges/Sponsor will be final and binding on all matters relating to this Sweepstakes. Potential winners are subject to verification of eligibility and compliance with these Official Rules. Limit of one (1) monthly prize per household for each monthly Sweepstakes Entry Period. A monthly Prize winner is also eligible to win the Grand Prize.

PRIZES: One (1) Grand Prize of a \$500 Account Deposit will be available to be won, as noted in the Random Drawing Schedule listed above. The three (3) monthly Prizes to be awarded for each of the five (5) Sweepstakes Entry Periods will consist of an Account Deposit of either \$250, \$100 or \$50 corresponding to the Grand, First and Second Prizes, as detailed in the Random Drawing Schedule above. Total Value of the Grand and all monthly prizes available to be awarded during the Promotion Period: \$2,500. Prize is not transferable. No substitution allowed except, at Sponsor's sole discretion, where a prize of equal or comparable value may be substituted. WINNER NOTIFICATION AND VERIFICATION: Potential Prize Winners will be required to complete and return a Prize Acceptance Form and Publicity/Liability Release ("Prize Form") before being awarded a prize. The Prize Form must be returned within the required amount of time noted at time of prize notification. Prize award is subject to verification of potential Prize winner's identity and eligibility to Sponsor's satisfaction. In the event that any potential winner cannot be contacted, fails to return the Prize Acceptance Form within the required timeframe, refuses the prize, or is disqualified for any reason, Sponsor will select an alternate potential winner in a random drawing from among all remaining eligible entries, if time permits, up to three (3) alternates. Winner must have an open Smart Sense Savings Account in good standing in accordance with the terms described in the Broadview FCU Account Disclosures and Agreements in order to receive the prize. Any automated and/or electronic submission of entry (including but not limited to entries made using any script, macro, bot, or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. If, in Broadview FCU's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if computer virus, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Sweepstakes.
